
















Enacting the Ordinance

In Okinawa Prefecture, despite long-standing efforts to eliminate unfair discrimination, there still exists prejudice and unfair discrimination based on certain attributes such as race, nationality, or background, which are difficult for individuals to change, particularly in public spaces and on the internet. Additionally, there is insufficient understanding of diversity in sexual orientation and gender identity. To address these issues more effectively and promote efforts to eliminate them throughout society, this ordinance was enacted.

Purpose

To promote the elimination of unfair discrimination throughout society and strive to create a society without unfair discrimination.



Basic Principles

Under the recognition that no one should engage in unfair discrimination based on race, nationality, creed, gender, sexual orientation, gender identity, social status, origin, or any other reason, the prefecture, municipalities, residents, and businesses cooperate with each other to promote the formation of a society without unfair discrimination throughout the entire society.

What is "Unfair Discriminatory Behavior Against Individuals of Foreign Origin"?

This refers to actions or expressions that openly announce intentions to harm the life, body, freedom, honor, or property of individuals of non-Japanese origin, thereby promoting or inciting discriminatory attitudes towards them. This includes significantly derogatory treatment of individuals based on their origin from countries or regions outside of Japan, with the purpose of instigating their exclusion from the local community.



About Hate Speech

Discriminatory behavior that defames and insults specific ethnicities or nationalities with the aim of excluding them from society is generally referred to as hate speech. However, there is no legal definition of hate speech, and its scope is not clearly defined.

Hate speech may also be used interchangeably with "Unfair Discriminatory Behavior Against Individuals of Foreign Origin," but can also simply mean "expressions of blatant hatred."

Hate speech is not only unsettling and repugnant to people, but it can also undermine human dignity and foster discriminatory attitudes. Therefore, it is behavior that should never be condoned.

It is crucial for everyone to firmly hold the awareness that hate speech is unacceptable.
